

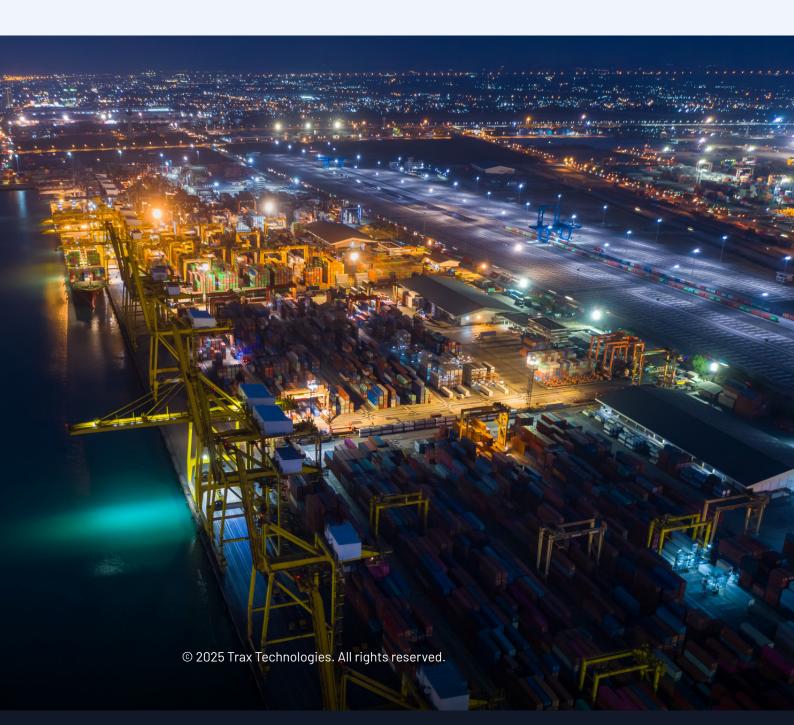

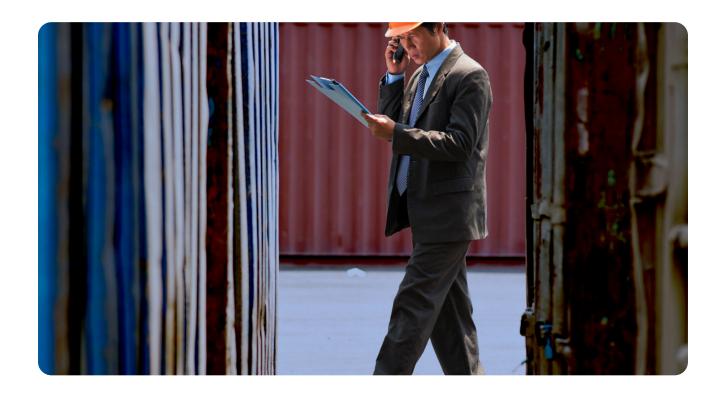
The Challenge: Complex Global Operations Requiring Rigorous Governance

The Solution: Balancing Rigorous Compliance with Exceptional Efficiency

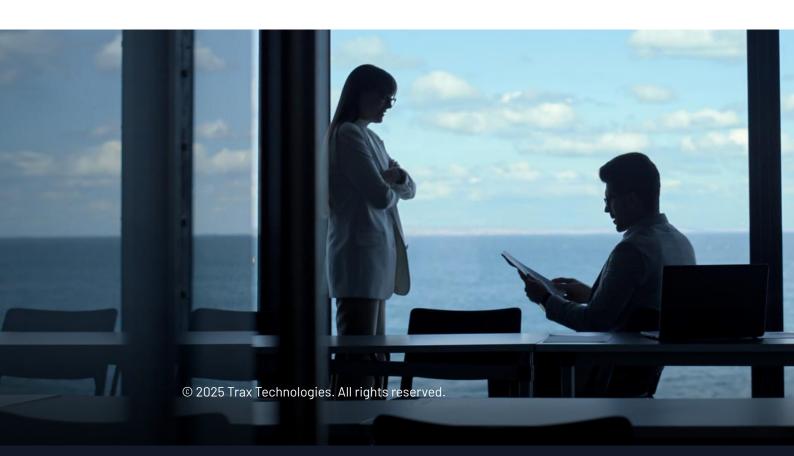
Trax's approach went far beyond traditional freight audit and payment services. The solution began with a fundamental reinvention of how the company handled logistics data across a complex global footprint:

- The system maintains complete transparency, with a full, verifiable audit trail accessible to both parties
- Despite this thoroughness, the process maintains high throughput performance—a rare balance that most providers can't achieve
- The system intelligently focuses human intervention only where needed, using automation to handle routine operations

This balance of meticulous governance with operational efficiency is what enables the company to manage over \$2 billion in freight spend without compromising on accuracy or compliance.



Unified Global Data Platform

Alongside rigorous compliance, the partnership delivers exceptional data management capabilities:

- The platform consolidates carrier spend from various global sources into a single repository
- Data integration systems transform fragmented information into actionable intelligence
- The platform normalizes data across multiple dimensions: measurement units (pounds, kilograms, square footage), currencies (operating across 24 different currencies), languages (supporting 14 languages), and regional requirements (spanning 147 destination countries)
- Beyond simple normalization, Trax extends the data with company-specific business context and categorization
- This creates not just standardized data but a dynamic, accessible source of truth with specific business meaning

The company can now run comprehensive reports across billions in spend in minutes, with 100% accuracy—something that would have been impossible before.

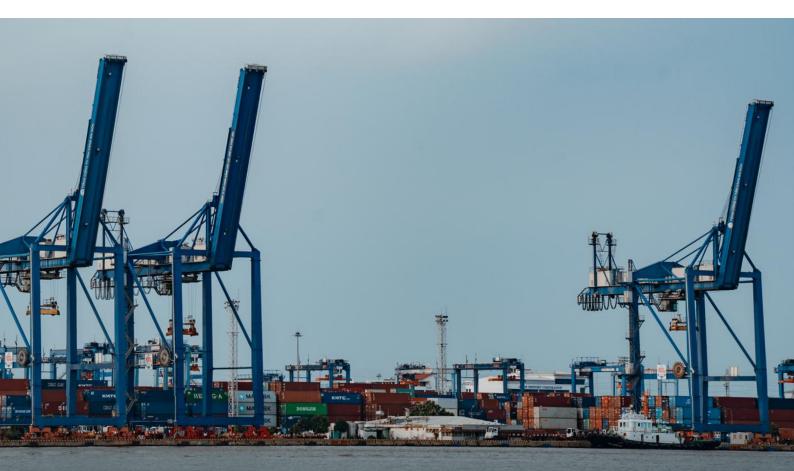


Data Integration and Contextualization

- Most importantly, Trax extends the data with company-specific business context, using rule-based configuration to categorize shipments by segment, business unit, and other critical dimensions

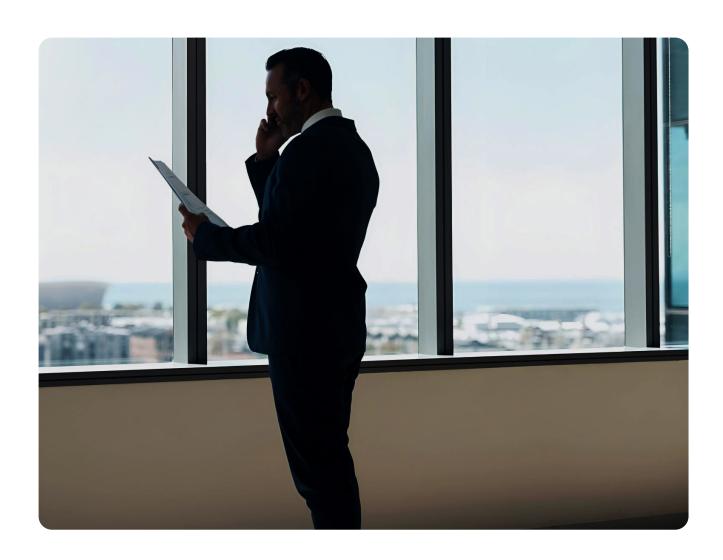
This means data arrives already contextualized with the company's specific business requirements, enabling more meaningful analysis and decision-making.

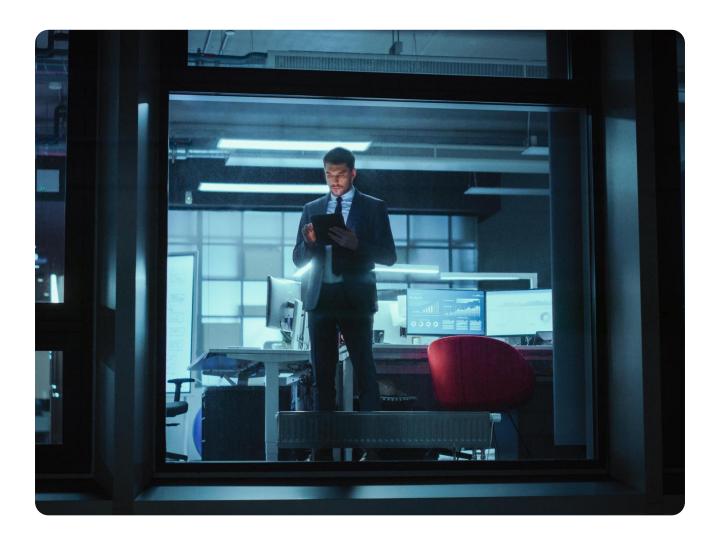
